■ MAINTENANCE

1. The outer case is machine washable. Before washing, remove inner contents by opening the Velcro fastened strip at the top of the pad. Gently, slide out the inner pad and foam padding.
2. When the pad is not being used, store it in a dry location. Do not store near intense heat or an open flame.
3. Keep the pad out of reach of pets and young children.

■ OPERATION

1. Place the pad upright on an office chair or car seat as shown.
2. Adjust the included strap to secure the pad to the chair or seat.

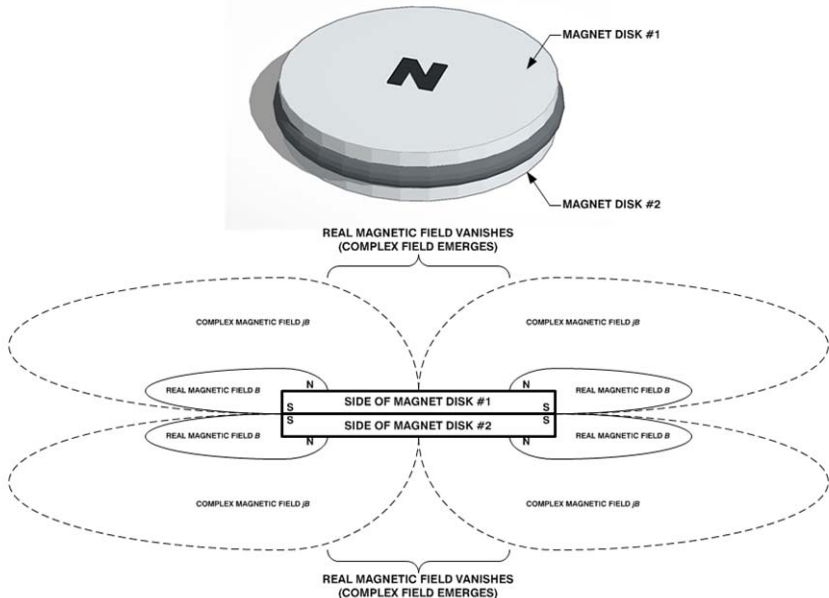
